Facilitating and implementing space-themed art & wellness programs---numerous programs implemented with children around the world (e.g. Nemours Children's Hospital; The Clayworks at Disability Supports; Las Cruces Space Festival; Play by COMO Island Astronauts; Jersey Ocean Week); Piccadilly Sea & Space Art Mosaic (\$3,750). Otherwise, primarily travel expenses in support of this programming (\$907). We engaged with over 2000 children across this programming--also supported several online programs with a few hundred other children. To date, globally, we have engaged with over 7000 children and almost 100 different organizations.

Awarding scholarships & grants to art students & artists who want to develop their own space-themed 'art & healing' ideas---closing year supporting the "Your Song My Song" art/wellness grant activity through their Water Musical programming. Across the 7 local community shows they performed this year they engaged with over 200 children and adults and 5 local conservation groups, and supported 4 small local venues and 10 artists.
